Medical Industry Accident Trends and Controls

The most prevalent exposures for Texas Medical Group Operations are falls, strains, cut/punctures, miscellaneous and struck-by.

To Prevent:

Falls:

- Download the "Slip/Trip/Fall Prevention Guide for Health Care Providers" from texasmutual.com or http://tmgworkcomp.com
- Develop system to identify patients that are more likely to fall and require assistance.
- Use slip resistant floor surfaces.
- Implement footwear policy and wear slip resistant shoes. Sample vendors: Shoes for Crews, Tredsafe (Wal-Mart), and SafeTStep (Payless Shoes)
- Spills should be cleaned up immediately. Use wet floor signs.
- Develop a housekeeping schedule. Conduct facility self-inspections.
- Train employees in proper use of ladders and step stools. Use three point contact technique for ladder egress. Secure or use a ladder stabilizer.
- Employees should use precaution during egress to client homes. Report unsafe physical work conditions.

Strains:

- Conduct an assessment of patients and develop procedures for safe patient handling, lifting or transfer assistance and include requirements for additional personnel for non-ambulatory or difficult lifts
- Utilize various patient lift devices (i.e. stand-assist, ceiling mounted lift, portable lift devices, slide and transfer boards, draw sheet, trapeze bar) Train employees in equipment usage.
- Maintain lift aid equipment (i.e. patient lift, dollies, carts).
- Provide adequate staffing levels to deal with the workload to avoid single patient lifts.
- Train employees in Preventative and Management of Aggressive Behavior while working with patients.

Struck/By:

- Download OSHA's "Guidelines for Preventing Workplace Violence for Healthcare Workers"
- Conduct an assessment of patients and develop procedures for safe handling of potentially violent patients including working in teams
- Conduct de-escalation training for care givers of mental patients
- Remove objects from rooms that can be used a projectiles or weapons
- Develop a security system with guards who can be alerted when patients, patient guests or co-workers become violent
- Encourage workers to report threats and aggressive or violent behaviors from patients, co-workers or visitors
- Ensure that parking lots are well lit, striped and marked to avoid struck-by vehicle accidents

Cut/Punctures:

- Use safer needle devices (i.e. needleless devices, self-sheathing, retractable, self-blunting, etc.).
- Dispose of needles into sharps containers.
- Train employees in universal precautions and the safe use needle devices.

Motor Vehicles:

- Use authorized drivers and specifically discuss your cell phone and seat belt policies during the new employee orientation process!
- Require drivers to complete online defensive driving course or refresher courses.
- Maintain vehicles, conduct documented inspections of company and employee owned vehicles.
- Mandate seat belt usage for drivers and passengers.
- Avoid or restrict cell phone use while driving.
- View TMIC online streaming video "Distracted driving: lasting consequences of distracted driving".
- Develop a Fleet program which includes a policy statement, driver duties, write and explain the hands-free only or stop-to-talk cell phone policy and seat belt rules, check motor vehicle records before hiring and annually, require driver safety classes, vehicle inspections, thorough accident investigations.
